## WHAT PERSONAL DATA WE COLLECT

We only collect your personal data as necessary to allow us to conduct business with you. We will not sell or rent this information to anyone. Please let us know if your personal data needs to be updated. If the information we hold is inaccurate, we may not be able to conduct business with you (for example, if we are unable to contact you by phone or email).

We collect the following type of personal data:

- Identification data
  - This includes your name, telephone number, email address and business address.
- Non-identifiable data
  - On our website, we use "cookies", but it is only used to give an improved experience when you
    use our website. More information on these cookies can be found at the end of this document.

### **HOW WE USE PERSONAL DATA WE COLLECT**

We will use your personal data within the laws and regulations. We use your information to respond to you, regarding the reason you contacted us. We will not share your information with any third party outside of our organization (unless the law or regulations require us to do so), other than as necessary to fulfil your request, e.g. to assess usage requirements or to ship an order or to arrange a third party contractor for business purposes.

Unless you ask us not to, we may contact you via email in the future to tell you about specials, new products or services.

## HOW LONG WE KEEP YOUR PERSONAL DATA

We will retain your personal data only for as long as required by statutory laws and regulations and/or as needed to fulfil or conduct business with you.

## **PERSONAL DATA WE SHARE**

We use Google Analytics as part of our website. It doesn't contain any personal information that can identify any individual person. It's just so we know how well our website is working, and how often people visit.

We also use an outside shipping company to ship orders, and a credit card processing company to process payments for goods and services provided by Towrite.

These companies do not retain, share, store or use personally identifiable information for any secondary purposes beyond filling your order.

We work closely with a few third parties to provide specific services relating to our Electric Vehicle business. If you are within the area where one of these third party operates, we may share names, and/or other contact information that is necessary for the third party to provide these services to you. These parties are not allowed to use personally identifiable information except for the purpose of providing these services.

### **HOW WE PROTECT YOUR PERSONAL DATA**

We take precautions to protect your personal data against unauthorised disclosure, access and use:-

- We implement system security to ensure that data is recorded and processed in a secure manner.
- Only employees who need the information to perform a specific job (for example, billing or customer service) are granted access to personally identifiable information.
- The systems where personally identifiable information is stored are kept in a secure environment.
- All of our employees who have access to your personal data are required to enter into non-disclosure
  or similar agreements, which imposes obligations on them to comply with our data privacy and
  confidentiality requirements.
- We also require any third parties that we share your details with (outlined earlier in this document) to comply with any applicable privacy and confidentiality requirements.

## YOUR ACCESS AND CONTROL OVER YOUR DATA

Under applicable data protection laws and regulations, you have rights:-

- To see what data we have about you, if any.
- To change/correction of any data we have about you.
- To have us delete any data we have about you.
- Express any concern you have about our use of your data.
